### REPRESENTATION

#### **New Sessional GPs Subcommittee**

The results of 2010's election to the Sessional GPs Subcommittee have recently been announced, marking a major step forward in improving sessional GP representation on the General Practitioners Committee. For the first time, members were elected on a regional basis to ensure representation from across the UK. The newly elected members are:

As we reported in our last newsletter, significant changes have been made to the way in which the subcommittee operates. Following the report of a working group set up last year to review the representation of salaried and locum GPs, the subcommittee has increased in size from 8 to 16 members, has an executive, which sits on GPC and handles day to day work, and, importantly, now has delegated authority for issues that relate wholly or primarily to sessional GPs.

• BMA Sessional GPs Conference



A record 46 candidates stood for election to the subcommittee, representing a diverse section of the sessional GP workforce. An equal number of salaried GPs and locums, both young and more experienced GPs, put themselves forward. Their election statements highlighted several common themes, including the recognition of locum and salaried work as a valid and positive career choice, the need to make revalidation a fair process for sessional GPs, and a desire for all GPs, regardless of their contractual status, to have equal opportunities in general practice.

Vicky Weeks, who has been re-elected as the Chair of the subcommittee for 2010-2013 said, "These elections represent an exciting step forward and I'm delighted that a number of fresh faces have joined the subcommittee". She said that the subcommittee would play a "fundamental role in tackling the big issues facing this expanding and important section of the workforce".

The subcommittee's first meeting took place on December 2nd 2010, at which it discussed the Health White Paper, revalidation and prescribing numbers for sessional GPs, among other subjects. Elections for the subcommittee's Executive Committee also took place at the meeting. Mark Selman was re-elected as Deputy Chairman and Jessica Harris and Stephen Bassett were elected to join him and Vicky Weeks on the Executive Committee.

# NHSWHITE PAPER

## **CONTRACTUAL AND PROFESSIONAL ISSUES**

#### The NHS White Paper

The NHS White Paper, 'Equity and Excellence: Liberating the NHS' was published by the Department of Health in July, and outlines major changes to the NHS in England. Among other proposals, it says that GP practices will be grouped into consortia, which will take control of budgets to commission services for patients.

The GPC has produced guidance on how the proposed changes will affect locum and salaried GPs and how they can get involved in commissioning, which you can find on the **BMA website**.

The changes will affect all GPs, and we firmly believe that sessional GPs should be included in local discussions about their implementation. The GPC has advised Local Medical Committees (LMCs) to communicate regularly with all GPs in their local area about how the plans are developing and to help ensure that the proposals develop in a manner that is acceptable to the local profession. It is therefore vital that you contact your LMC to ensure that you are on their mailing list. Contact details for all LMCs are available on the **BMA website**.

Sessional GPs may also find that they are well placed to put themselves forward for leadership roles in the development of the 'shadow' commissioning consortia that are expected to be in place by 2011/2012 and are already beginning to be formed in some areas. We would strongly encourage sessional GPs to consider putting themselves forward for these roles.

# **Revalidation**

#### General Medical Council

The General Medical Council (GMC) ran a consultation on its proposals for revalidation between March and June 2010 and has now published its response to the submissions it received. In the BMA's response to the consultation, we highlighted our concerns about how the proposals would affect sessional GPs. We were concerned, as were several other respondents, that sessional GPs, and especially peripatetic locums, would face significant hurdles in compiling the evidence required to revalidate. The BMA strongly believes that no one group of doctors should be unfairly disadvantaged by the proposals. To read the full BMA response, see the **BMA website**.

The GMC's response was published on October 18th 2010. We were pleased to see it acknowledge our concerns regarding sessional GPs, and affirm a commitment to ensuring that revalidation is sufficiently flexible for all types of doctor to access. It acknowledged that the current proposals for the evidence doctors will be asked to submit, with their focus on clinical audit and feedback forms from patients and colleagues, would present significant challenges for GPs who were not based in one practice. However, the GMC response lacked significant detail on the future shape of revalidation, including how it might be adapted to meet the needs of sessional GPs. The subcommittee recently wrote to the GMC to raise its concerns about the ability of locum GPs to access patient records for clinical audit and whether this might breach patient confidentiality. The GMC's reply confirmed that implied consent would be sufficient in cases where patient data is being used for the purposes of clinical audit. This means that if a locum sees a patient and then subsequently wishes to access the records of that patient held by that patient's regular GP, they can do so without breaching confidentiality if this data is required for a clinical audit and the conditions are in place for implied consent to be given.

#### RCGF

The RCGP are proposing the standards for revalidation for GPs. Version 5 of its 'Guide to the Revalidation of General Practitioners' was published in December 2010 and is available on the **RCGP website**. It recognises that the overall standard of evidence achieved must be the same for all GPs but allows for different methods of evidence collection by 'special groups', including peripatetic locum and Out Of Hours doctors.

These proposals followed the completion of the RCGP revalidation pilot for sessional GPs, which confirmed our concerns about the specific difficulties faced by this group of doctors. Laurence Buckman, the Chairman of GPC, has written to the College to request that a second pilot now be run to test the feasibility of the revised proposals.

The General Practitioners Committee will continue to work with the GMC and the RGCP to try and ensure that revalidation is fair for all GPs. BMA members can read updates on the progress of revalidation on the **BMA website**.

#### Pathfinder Pilots

The Department of Health's Revalidation Support Team (RST) is continuing to oversee 10 pathfinder revalidation pilots, which are due to finish by the end of March 2011 to allow time for analysis of the results. The BMA has representatives on each of the separate pilot steering groups and GPC representatives contribute to the groups in London, South Central and Dorset.

If you are taking part in one of the pilots, we would urge you to continue to participate and ensure that you provide feedback on your experiences. It is vital that sessional GPs have their say so that revalidation can be properly adapted to suit their needs.

### **Contacting your Local Medical Committee**

LMCs are the local representative body for GPs. The LMC that represents you should keep you informed about any issues affecting general practice locally. It cannot be stressed enough how important it is that the LMC has your up-to-date contact details. You can find out how to get in touch with your local LMC on the **BMA website**.

## **Sessional GPs: Your Pathway to Success**



## **DEVOLVED NATIONS**







#### Northern Ireland

Dr Thomas McCaw has recently been co-opted to join theSessional GPs Subcommittee as the Northern Ireland representative. He is one of two sessional GP representatives who have a seat on the Northern Ireland General Practitioners Committee, along with Dr Peter Campbell.

#### Wales

Dr Stephen Bassett is the Welsh representative on the Sessional GPs subcommittee. He has been elected to the subcommittee's newly constituted Executive Committee, affording a seat on GPC along with GPC Wales.

Sessional GPs make up nearly half the GP workforce in some Health Boards in Wales, and are a vital part of all Health Boards. GPC Wales aims to ensure that sessional doctors receive as much information from Health Boards and the Welsh Assembly Government as contracted colleagues.

#### **Scotland**

Dr Mary O'Brien has been elected as the Scotland representative on the Sessional GPs Subcommittee and attends Scottish GPC (SGPC) meetings.

GPs in Scotland continue to have to be registered with a 'host' NHS Board and then apply to other NHS Boards in order to be able to work in those areas. The SGPC negotiators are continuing to push for a single National Performers List for Scotland and raised the issue at a recent meeting with the Practitioner Services Division of NHS Services Scotland. At the meeting, they also discussed sessional GPs being given their own prescribing numbers, which is being taken forward on a UK-wide basis by the Sessional GPs Subcommittee.

Scottish GP partners and salaried GPs have a payment for their appraisals covered by the global sum but no funding is provided for locum GP appraisal. Tayside Health Board had provided this funding locally but withdrew it in April 2010, which SGPC vociferously opposed. SGPC is continuing to pressure the Scottish Executive Health Department to provide central funding.

#### Locum GP guidance on negotiating fees

This is a reminder that guidance for locum GPs on negotiating fees is available to BMA members on the **BMA website.** The guidance was been developed by the BMA (including the General Practitioners Committee and the GPC Sessional GPs Subcommittee) and the National Association of Sessional GPs (NASGP).
