Coronavirus (COVID-19): SEND risk assessment guidance

This guidance advises local authorities to conduct risk assessments and makes suggestions and recommendations for how that might be done in collaboration with educational settings and parents.

This guidance document relates particularly to children and young people whose need for hands-on care or whose behaviours mean that there are more, or more nuanced, risks to be managed than for the majority of children and young people with EHC plans.

- Virtual lessons and live streaming
- Providing pastoral care remotely
- Personal data and GDPR

Baroness Doreen Lawrence will lead a review into the impact of coronavirus on black, Asian and minority ethnic communities, the Labour Party says.

The campaigner and mother of murdered teenager Stephen Lawrence has been appointed as Labour's race relations adviser by leader Sir Keir Starmer.

The review will examine why the virus appears to disproportionately impact those from ethnic minority backgrounds.

The government has also commissioned an investigation into the issue.

<u>The Intensive Care National Audit and Research Centre</u> found that 34% of more than 4,800 critically-ill patients with Covid-19 identified as black, Asian or minority ethnic.

This is despite only 14% of people in England and Wales being from ethnic minority backgrounds, according to the 2011 census.
